APPROVAL OF MINUTES & GENERAL MONTHLY FINANCIAL REPORT

President Rooney drew the attention of the Board to consider the September 14, 2022, draft minutes. Fred Jones advised striking the first sentence of Wes McCary's report (Director Owen has asked for proposals for infrastructure funding). Mike O'Brate moved to approve September 14. 2022, minutes as revised. Fred Jones seconded the motion. Motion passed.

President Rooney next drew the attention of the Board to review the September 2022 financial report documents. Fred stated there are zero expenditures in the water conservation line item. Mark explained that grants funded the water conservation expenses, the POC has not occurred this year, and the ICARE expenses will be from the ICARE Grant. Fred noted that "Decision Memos" attached to the agenda would be beneficial for keeping track of expenses, especially through grants. Fred Iones made a motion: Approve the financial reports and payments for September 2022 as presented at this meeting and submit them for the annual audit. Randy Hayzlett seconded the motion. Motion passed

President Rooney signed and submitted the financial documents.

Management Program: Reports and Recommendations

Water Commissioners Report, Mike Mever, DWR

Mike Meyer announced the river bailiff position in Garden City had been filled by Ethan Andrews. Still have one position to fill. There have been no new MYFAs submitted; they are still holding at 50. DWR measured the alluvial wells up and down the Arkansas River, and the levels are down to no surprise. DWR measures the alluvial wells on the Ark three times a year. Mike added that change applications have decreased except for test logs where there is a backlog.

DWR Draft Rules and Regulations

Mike Meyer spoke about the DWR Draft Rules and Regulations, an informal draft rule process. Stakeholders will provide feedback once a good draft has been completed. The draft would then go to the Department of Administration, which will critique them for grammar, consistency, and redundancy of other regulations. Once that is done, then a public hearing will be set up. The chapter of K.A.R. 5-1 focuses on regulations of metering.

K.A.R. 5-1-4 Water Flowmeter Specifications.

The Chief Engineer will approve flowmeters based on specifications. Along with the specifications already in K.A.R. 5-1-4, the following may be added:

- > Battery meters must have a minimum of 2-year battery life.
- ▶ Propeller and turbine meters must have a sensor that is at least ½ the I.D. of the meter.
- > Flow tubes must be identifiable (i.e., have a label)
- > Saddle and insertion meters must indicate the I.D.

K. A. R. 5-1-5 will be rescinded, which was the regulation related to variances.

<u>K. A. R. 5-1-6 Water flowmeter installation specifications</u>. Most flanged meters need cross-drilled bolts to secure the meter to the pipe. And then also ultrasonic and electromagnet meters, if you're going to inject, need to be downstream of the meter.

K. A. R. 5-1-7 Requirement to install a water flowmeter or other suitable water measuring device. Removed the language allowing one meter for multiple points of division.

K. A. R. 5-1-8 Water flowmeter maintenance. If at any time the flowmeter fails, the owner shall promptly get the meter repaired or replaced. Wording added to 5-1-8 would require the owners of a water right to maintain a log of meter readings every 14 days, and this data may be considered a prompt cessation of a violation.

The Board commented on the 14-day log. Some feel that once a month would be enough. However, energy Bills are not backup records; they are a last-ditch scramble to provide paperwork.

K. A. R. 5-1-9 Criteria to determine when a water flowmeter is out of compliance. Along with the criteria already in place, could add 1) meters with a dead battery are out of compliance 2) Meters that are imminently likely to become out of compliance may be considered out of compliance (i.e., the meter shows signs of failing soon)

K. A. R 5-1-10 Duties of water right owner when a water flowmeter is out of compliance. As soon as the flowmeter is out of compliance, the water right owner or the authorized designee shall notify the State the next business day. This is on the honor system and only takes a quick phone call. The Chief Engineer should receive notice within 15 days of any repair work completed to the meter or modifications to the required straight pipe. The Chief Engineer shall receive invoices/work orders for meter repair work.

The ultimate goal is to get water rights owners to read their meters, keep better records, and communicate with the State.

Project Term Permit, 20229051, Cobalt Cattle

Mike Gesling and Lucas Christianson from Cobalt Cattle were present for any questions and additional comments. Jason Norquest explained the Project Term Permit 20229051. He stated that this is a term permit proposing to combine the wells' authority to meet the cattle operation's needs (stock use). About four years ago, they converted water rights 4,099 and 18,097 to dual-use (irrigated / stock). Those current limitations will remain the same. Water rights 38,448, 39,462, 39,463 and 39,464 currently don't meet minimum spacing from 15,015 (neighbor well). These wells are not good and will not be pumped unless for an emergency. Jason noted the conversation with the neighbor, and he had no concern about it since it is a stock project and doesn't believe he will be affected. Mike Meyer noted he has been working on this project since 2017. At that time, they needed options to get the water where they needed it. GMD3 reviewed a term permit to pipe water in from a well down by the cemetery. DWR worked with Cobalt Cattle to get a WCA (water conservation area) in 2017, but it didn't meet the statutory requirements. In 2018 the State introduced the dual-use concept-piping water in and better managing the small wells. Two wells were over-pumped a couple of years ago, causing a steep fine. Clay Scott moved to waive the well spacing and the single well rules regarding term permit 20229051 with limitations on the smaller wells pumping under 100 acre-feet pumping up to 100 acre-feet and those larger remaining at their current limitations.
