## **APPROVE AGENDA**

Vice President Hayzlett asked to consider the agenda for the November 3rd meeting. Kent Dunn made a motion to approve the agenda as presented. Garret Love seconded. The motion passed.

#### APPROVAL OF MINUTES AND GENERAL MONTHLY FINANCIAL REPORT

Vice President Hayzlett drew the attention of the Board to consider the draft minutes from October 11, 2023. <u>Garret Love moved to approve the October 11, 2023. minutes. as presented. Clay Scott seconded the motion. Motion passed.</u>

Vice President Hayzlett next drew the attention of the Board to review financial report documents.

Bret Rooney motioned to approve the financial reports and payments for October 2023 as presented at this meeting and submit them for the annual audit. Clay Scott seconded the motion, Motion passed

Vice President Hayzlett signed and submitted the financial documents.

## **Correspondence / Recognitions / Public Comments**

Zachary Gale wanted to state that, to his knowledge, the members of Hamilton County have never met with an attorney on the issue of suing GMD3. Some words may have been taken out of context. A conversation with Mark at the end of the last annual meeting when Zach stated if the process is going to be drug out for six years like Hodgeman County, then he would have to go back to the members and inform them that is Mark's tactic and would have to look at other legal options. That is all to his knowledge, and there have been no formal threats from the petitioners of Hamilton County.

#### **Executive Session**

Mark Rude advised there is a resolution to go into an executive session to talk about the Hamilton County situation in light of the AG's opinion. Tom Adrian is on the line, and he recommended considering attorney-client privilege. At 9:22 am. Clay Scott motioned to go into executive session for 30 minutes and exclude any board members who have signed the petition to bring litigation against the Board. Garret Love seconded. Motion passed.

The meeting was called back to order at 9:52 am.

Bret Rooney moved to have legal counsel present the petitioners, on behalf of the Board, questions relevant to the addition or withdrawal of lands from the district. Fred Jones seconded. Motion passed.

#### **Management Program: Reports and Recommendations**

Water Commissioners Report, Mike Meyer, DWR

Mike Meyer stated the office is business as usual. To date, three positions are being advertised. WCA regs will be coming out for review. The goal is to have a 45-day review turnaround and then be ready for final review. The ARCA (Arkansas River Compact Administration) meeting is coming up the first week of December in La Junta, Colorado.

## **Hamilton County Petition Request**

Mark stated the most relevant thing is the AG opinion in the board book. It concluded that the Board was not in violation of KOMA.

### **Draft revised Management Program Document**

Mark announced he has the Management Program document printed out for those who want a copy. Page 16 of the board packet contains the regions for next year's ICARE mailing. Mark noted a correction on the SSS area in Stevens County, which reads 7,400; it should be 74,000. Garret stressed that using newer and better data would show a more forward look. Clay Scott added that based on the run scenario. and the 30% variation in tweaking the model. As we move forward, KGS should be able to add a number to the well, pumping per minute and % less. Mark reminded everyone that the numbers on the map are not from the model but from the QStable graphing. Clay asked what the numbers mean on the map on page 18 of the board book. Mark stated that is the number of cattle heads in feedlots and dairies.

Policy and Legal

Chairman Clay Scott reviewed the discussions held at the Policy and Legal Committee meeting on October 31, 2023.

HB 2279 COMPLIANCE: This will probably be on the agenda from here on out for a while. Action on the WaterSMART grants will be brought to the Board.

KWO OGALLALA COMMITTEE, NOVEMBER 28-29 and VIJAY RAMASAMY VISIT, GOVERNORS WATER ADVISOR NOVEMBER 29: Announced

#### FEDERAL WATER POLICY DEVELOPMENT.

GMDA, GMD3 TO HOST JANUARY CONFERENCE: Jason Norquest is President-Elect; the Conference is January  $23^{rd} - 25^{th}$  in Nashville, Tennessee.

2023/4 FARM BILL UPDATE: to date, there is no update to report as Hill conditions are in flux.

#### HOUSE APPROPRIATION-PASSED HR4393 REPORT LANGUAGE

Mark added there have been a lot of conversations on authorizing high plains study. One of the Five Elements was major water transfers. The committee put it in the report authorizing the US Army Corps of Engineers to use existing funding to collaborate with non-federal entities to implement those projects further. Mark announced he, Jason, Clay, and Randy would have a fifteen-minute meeting with the USACE regional director at the NWRA meeting.

WRDA REQUESTS: High-plains study. We are looking at a feasibility study and updating the past work of the WRDA bill.

GMD3 HAS RECLAMATION AND ARMY CORPS MEETING IN NOVEMBER: we should also be able to meet with the Bureau of Reclamation to discuss extended drought and declining aquifer mitigation funding.

WIFA OF ARIZONA RFI: There was a Request For Information to the public regarding Water Transfer into that state.

## PREVENTABLE WASTE OF WATER-SPRINKLER IRRIGATION IN HIGH WIND CONDITIONS

Mar stated that one thing that makes some people livid is water waste from sprinklers in high wind conditions. Clay asked Mark, when the office gets those calls, do we forward the information to DWR? Mark added that we do when it is a specific location; otherwise, if it's just a general concern, we don't. Mike Meyer stated he refers the calls to GMD due to verbal agreements that GDM3 wants to handle the waste of water issues. Chris Law noted that out of ten calls, there may be one with a specific location. In that instance, GMD3 will try to round someone up to correct the issue. If more muscle is needed, then GMD will be calling DWR.

## Ogaliaia Committee

Randy Hayzlett announced that the Ogallala Committee will meet on November 28<sup>th</sup> and 29<sup>th</sup>. The committee may want to have Troy Dumler give a presentation. Also, ViJay Ramasamy would like to visit with some board members on November 29.

Clay Scott added he can see GMD3 working on HB 2279 and the stock water flex / other options at every Policy and Legal meetings for some time.

## **Agency Reports**

<u>KWO</u>

#### Keadron Pearson

Keadron announced that KDA (Kansas Department of Agriculture) was awarded nearly \$25 million from the U.S. Department of Agriculture to support water conservation and groundwater management in the High Plains Aquifer. Mark added that it included 12 positions to help producers with technology assistance. The concept was to put two staff in each GMD office.

Keadron also announced that the two Technical Assistance and Water Projects Grant grants are open. Smaller municipalities would benefit from this and encourage those in small communities to check into it.

KWPPI (Kansas Water Plan Partnership Initiative), which includes excess funds from the Water Plan, is currently around 2 million dollars. More information is on the website; the deadline is January 29, 2024.

There are also two positions available to work with these grants. Based out of Topeka.

Keadron reminded everyone of the Governor's Water Conference next week. Kansas Water Authority is meeting in Concordia, KS, on December 13, 2023.

Lastly, Dawn has made her selections on each of the RACs for Chairs and Vice-Chairs, and each has accepted: Cimarron Chair is Adam Gerrond, and the Vice-Chair is Lucus Crouse. For the Upper Ark RAC, Abe Lollar is Chair, and Bill Simshauser is Vice-Chair.

Mark added the December meeting needs to change due to a meeting conflict. After discussion, the consensus was to move the meeting to December 18. Mark reminded everyone that the board-spouse luncheon would be after the meeting.
